- If you receive a security code **unexpectedly**, call cardholder or member services immediately.
- **NEVER** give anyone your online/mobile banking credentials... no matter what!
- Sign up to receive account notifications: transactions, balances, login alerts. etc.

In our fight against fraud, and to improve our members' experience, we added new features such as push notifications for our digital banking app, secure connection capability to safely connect your accounts between institutions, credit monitoring and goal setting within our app, along with many other behind-the-scenes improvements.

We have more exciting changes coming for 2026! While we will continue to make improvements and updates to keep your account secure, we are also bringing contactless (Tap to Pay) cards to our AFCU members. Stay tuned to our social media pages for more information on when you can expect to see this roll out!
